 - Tutorial support and additional breakout room support in Zoom sessions
- Trimester report cards will be accompanied by the student-led conferences that provide voice, authentic audience and accountability for students in their progress over the trimester and goals for upcoming learning.

- Innovations Public Charter School will transition to in-person instruction in an alternating schedule for all students able to attend in-person instruction = 2 days/week per student.
 - 8:00-2:45 school day
 - 2:45-5:30 after care / enrichment program for interested elementary-middle school students
 - 4-day instructional week: 5th day provides for teacher planning and distance learning for distance-only students
- Parent option survey will be conducted in mid-December for in-person instruction beginning in January 2021
 - o Distance learning option will be available to families needing that option
